## Chairman's Chat

The Branch AGM was on Sunday, 1<sup>st</sup> May, 2011 and for the first time for many years was held in the Headquarters Canteen, which was closed on the 1<sup>st</sup> April, this year as part of the Force savings.

There was an electrical fault in the Multi Purpose Hall and was considered unsafe for our meeting. Members of the Committee directed those members attending to the Canteen which had been set out for the meeting. Most members thought it was quite pleasant having large windows allowing plenty of light.



Dee Collins, ACC, was the guest speaker and spoke about her responsibilities in the Force and it's up to date trend.

All members of the Committee were elected en bloc. This year a buffet was provided by the 'Cob Shop', Ripley and was paid for by the Branch. Over 60 members attended and a raffle was held which raised £79.

Due to the closure of the Canteen we were unable to use the crockery but Ripley Boy Scouts came to the rescue with the loan of teacups and saucers. £30 was donated to them.

Frank Gregory has retired from his post as Treasurer and we thank him for his services to the Branch.

Due to the fact that no committee members were desirous of becoming Treasurer, I advertised the post in the last copy, to be published, of the Force

Newspaper, Upbeat. I did not receive any replies. Malcolm and Sean both made enquiries and I asked several members of HQ staff but to no avail. Sean had a positive reply from his friend, Keith Gibson, who lives in Ripley and who has had experience in finance and book keeping. After interview Sean and I proposed Keith to the Committee Meeting on the 18<sup>th</sup> July, 2011 and after meeting him, the committee agreed to accept him onto the Committee as an Associate member. The Rules relating to Associate membership do not allow him to be named 'Treasurer' so he will be known as the Financial Manager.

The Branch continues to register new members and I welcome them and hope that they will attend some of our social functions. If you know of any retired Officer who has not yet joined 'NARPO', please encourage them to do so.

Please remember the object of the Association, 'To safeguard the rights of members and to promote measures for their welfare, with particular regard to pensions'.

We will keep you posted.

## THE MUTUAL WELFARE FUND

It has become apparent from some of the questions asked recently, that there is a need to make clear the terms on which the fund operates.

Firstly it should be understood that it is operated by the Force, through the Finance Dept, with the assistance of our partners Sarasin Chiswell Ltd, through a committee. It is not operated by NARPO. We are members and have 4 representatives on the committee.

All officers of the Constabulary (Federated Ranks) are members unless they specifically opt out. Subscriptions continue to be levied on pay and / or pension until the age of 65 years, when pensioners who are members of NARPO become honorary members, receiving the full range of benefits without further payment. If members of the fund cease payment or do not join NARPO all benefits cease to be available.

Under the rules of the Mutual Welfare fund, paying members have had to subscribe to the Mutual Welfare Fund St Georges Police Trust and the Convalescent Home as a complete package. However it was agreed at the Annual General Meeting of the Mutual Welfare Fund that with effect from 1<sup>st</sup> April 2011, paying members of all three funds will have the right to subscribe to each one as a separate entity.

The Benefits and subscriptions for each element are as follows:

- 1- Convalescent Home – monthly subscription of £5.42p.  
This is the monthly subscription required by the Home to enable Officers to attend for a period of 11 night's convalescence, subject to being a paid up member for a year.
- 2- St.George's Police Trust – monthly subscription of 87p.  
The trust makes the provision of a weekly allowance to orphans who are under the age of 16 years or who are still in full time education. (Several are still in receipt of this allowance in Derbyshire.)
- 3- Mutual Welfare Fund – monthly subscription of £2.44p.  
Benefits as below:
  - i. Payment of out of pocket and travel expenses to Officers attending the Convalescent Home at Goring on Thames.
  - ii. A retirement gift is paid to all members retiring from the Force. The gift is currently £900.

- iii. Financial Assistance may be given to any member who has been put to exceptionally heavy expense owing to sickness, bereavement or other causes over which the Officer has no control.
- iv. A death benefit is paid to all members and pensioned members on the death of their spouses. The benefit is currently £800.
- v. A death benefit is paid to the spouse/nominee of all members and pensioned members. The benefit is currently £800.
- vi. A birthday gift, currently £15, is payable to all pensioners on attaining 70 year and annually thereafter.
- vii. An occasional grant of at least £55 will be paid at Christmas each year to all widows and widowers.

The above benefits from the Mutual Welfare Fund are dependant upon the Officer having been a paying member for the complete duration of their service.

NARPO's current representatives on the Welfare Committee are Len Smith (Chairman), Michael Watson ( Vice Chairman and Welfare Rep), Malcolm North (Welfare Sub Committee) and Sean Murphy.

Any information about Members who are ill or in need, should be passed to anyone of the above who ensure help is given where possible.

## First Policewoman in Derbyshire



It is with deep regret that I have to inform members of the passing of Mrs. Iris Guest, previously WPC (1) Iris Dobney. It was only when I contacted her daughter Elizabeth Humphrey, that she informed me that her Mother Iris was the first Policewoman in Derbyshire and I thought it would be remiss of the Branch and the Derbyshire Police if we allowed it to pass without a mention.

Iris joined Derbyshire on the 25<sup>th</sup> March, 1946. She attended the Police Training Centre at Bruce, Warrington on the 27<sup>th</sup> May, 1946. She came 10<sup>th</sup> out of a class of 26 with an average mark of 73%. She served at Ilkeston from the 24<sup>th</sup> August, 1946 and resigned on the 26<sup>th</sup> March, 1948 due to her forthcoming marriage to Sergeant (93) Guest based at Long Eaton. Her training certainly came in handy when she

rescued a neighbour from a house fire in about 1959 and was awarded a Certificate from the Society for the Protection of Life from Fire
