FOREWORD



It is my pleasure to be entering my fourth year as Chief Constable of Derbyshire Constabulary. It has certainly been a busy year, and I hope that I'm able to give you a flavour of what we've achieved.

This year we have embedded our new joint purpose with the Fire Service of *Making Derbyshire Safer Together* within a larger framework including our principles and our priorities; collectively these are known as the Three Ps. The Three Ps will define who we are as an organisation, allowing us to ensure that the great work that we do every day is directed towards a common goal, and providing focus for those making both strategic and operational decisions.

One of the priorities within The Three Ps is using technology in all aspects of our work, and as part of this we have committed to provide taser to every frontline officer who wants it, and to ensure 24/7 drone coverage throughout the county. I'm really pleased to say that we are well and truly on our way to delivering on these aspirations, with over three hundred officers having been trained so far in the use of taser, and a plan to deliver on at least a further one hundred trained officers per year from now on, as well as complete 24/7 drone coverage throughout the county being achieved mid-2019. This is really great news, and it demonstrates that we are fully committed to officer safety, especially in those areas of the county in which backup and specialist resources may be some distance away.

Talking of backup, this year we've had the exciting news that Derbyshire will obtain an additional three hundred officers over the next three years as a result of the national uplift programme. This is very welcome news, although it does not completely repair the damage of the last ten years. We are being very proactive about accelerating recruitment as we recognise the strain the front line is under, with an additional 50 officers and 20 PCSOs being delivered by the end of April this year.

As I discussed last year, Derbyshire is one of the first forces to implement the new entry routes to becoming an officer, and I'm pleased to say that we are now on our second cohort of Police Constable Degree Apprentices (PCDA) via the University of Derby, with the first cohort having recently entering their second year of studies. Whilst I remain to be convinced that it is right to shut down traditional entry routes, I am very supportive of our new colleagues and the skills they bring. We have also successfully placed our sixth and seventh officers onto the Fast Track to Inspector programme, and welcomed our first cohort of Police Now officers and two additional Direct Entry Inspectors into the Constabulary. These schemes are really important to policing throughout the country, as well as bringing new ideas and new ways of thinking into our organisation.

We've also recently seen a change in the Senior Leadership Team, with the appointment of Rachel Swann as Deputy Chief Constable, replacing Gary Knighton who retired at the beginning of last year. Rachel has already made a big impact in

the organisation (and on the national and international stage) with her command of the incident at Whaley Bridge in the summer of last year; I'll talk more about that later. Last year also saw both Divisional Commanders retiring, with Jim Allen being replaced by Dave Cox and Rachel Osborne being replaced by Hayley Barnett. I'd like to wish all of those who have recently retired the best of luck and a big thank you, but I also look forward to the positive impact that Dave and Hayley will have upon policing in Derbyshire and beyond.

It would be remiss of me not to mention incident which actually happened halfway through last year, Whaley Bridge. The incident itself has been covered extensively by the national and international media, but I'd just like to take this opportunity to say how proud I am of the organisation's response to what was the largest peacetime evacuation of residents in the UK. It was only through the professionalism of my colleagues, and that of our partners in the Fire and Rescue Service, that approximately 600 properties and 1,300 persons were saved from an inundation of 1.3 million cubic metres of water. It is no exaggeration when I state that our resources were tested to the absolute limit, with over 800 members of staff from our organisation alone being involved as the incident progressed over the fateful week. The incident put Derbyshire in the national and international spotlight, with visits from both the Prime Minister and leader of the opposition, and hammered home to me the importance of excellent leadership in the face of catastrophe.

In July last year we were honoured with a visit by HRH Princess Anne to our Joint Headquarters and Training Centre in Ripley; the first visit by a member of the Royal Family to our headquarters in over forty years. The Princess took the opportunity to meet with me and former Chief Fire Officer Terry McDermott to discuss the importance of collaboration, then went on to address colleagues from both organisations, selected guests (including the NARPO executive) and local dignitaries. The Princess was then taken to the Joint Training Centre for a demonstration of our capabilities, including a demonstration by the Fire and Rescue Service of specialist equipment being used to rescue a horse (thankfully a model of one) whilst being observed using our drones.

Last year I said that the year ahead was going to be a challenge with an uncertain political future. As I write this, we have just exited the European Union, and yet again our future is uncertain as none of us know what the reality of Brexit will be. However, I am confident that we are an agile organisation that is able to respond to uncertainty in a professional manner.

I consider Derbyshire Constabulary to be a family, with NARPO being an extension to that family. I hope that this summary of the past year has been a useful "family update", and that you will be heartened to hear that I continue to be certain that NARPO is the voice of retired police officers within Derbyshire.

I have now settled into the role of Branch Chairman, since unexpectedly taking over from Michael Watson at the 2019 Annual General Meeting. The Branch committee continues to be efficient and well organised, providing a rounded range of services to our members. To the best of my knowledge the Branch has complied with its statutory obligations in holding its AGM and regular committee meetings in timely fashion. The Branch is financially sound, allowing us the opportunity to make use of our resources for the benefit of members, without putting our finances in any jeopardy.

As I am sure all members are aware, 2019 was the centenary of our Association. In connection with this my wife Gail and I together with Sean and Eileen were fortunate to attend the national celebrations held at The Tower of London on 13th June, when the guest speaker was Her Royal Highness, The Princess Royal, Princess Anne. On a local level our very successful Gala Dinner and Drinks Reception was held at Chatsworth House on 13th September when a number of civic dignitaries attended.

Five members of the Branch were also fortunate enough to be presented to The Princess Royal during an official visit to Police Headquarters on 18th July.

Our regular social events have been held with events at Mickleover Golf Club, Buxton Conservative Club and Lumb Farm, Ripley. Plans are also in hand to extend them to Glossop and Chesterfield. **Social at Chesterfield now organised for the 24th June** Details of all forthcoming events can be found elsewhere in the Annual Report and on the website.

The coach trips organised by Michael Watson have carried on successfully throughout the year. May I take this opportunity to thank Michael, as he moves on to pastures new, not just for organising the coach trips and for his work as Vice Chairman and Chairman of the Branch but also for his unstinting service to the Branch as a committee member for over 40 years. Many thanks Michael.

An award for "The Community Officer of the Year", presented annually is now sponsored by the Branch. This is just one of the ways that we use to maintain good relationships with the Force. Another initiative that continues to run is the presentation of a document folder to all retiring officers. This is either presented on our behalf by the Chief Constable to officers who see him on retirement or is sent to those who choose not to avail themselves of a visit to Headquarters. The folders are packed with NARPO literature, an introductory letter from the Branch and a membership application form. My thanks to the Chief Constable and his staff for their assistance with this initiative.

We also have a regularly updated page on the Force Intranet, "Connect" allowing us to advertise our activities to serving officers and retired officers working with the Force in other capacities. Coupled with this we also attend all re-settlement courses and provide relevant and interesting information about the role of NARPO and our activities to officers and support staff planning to retire within a couple of years.

A further advance in our communications strategy is the introduction of a Facebook page, being administered by Ian Louch. It can be accessed from the website and is updated with forthcoming events and other news. The Facebook page complements our excellent website, which Pete Wise maintains for us and where all information about Branch activities can be found. My thanks go to Ian and Pete.

The Branch presently has just over 1,400 members. A substantial number of their records show only a name and address and, in some cases, not even a forename. The committee recognises that the welfare of its members is a primary responsibility. We have recently

agreed a plan to contact as many such members as possible to ensure they have no welfare or similar problems. **Please make sure that Sean has your full contact details.**

The Branch Annual General Meeting at 3pm on Sunday, 10th May 2020, in The Atrium at Police Headquarters will feature a short presentation by Tony Harvey of Harvey Howell Solicitors (a NARPO approved company) in relation to wills and Power of Attorney etc. It should be interesting and relevant to many members. There will also be a tea afterwards, partly sponsored by Harvey Howell.

We lost our Honorary President, Len Smith and Committee member Don Dovaston who both sadly passed away and former chair Michael Watson who has moved to the Yorkshire coast to be near his family.

You will see from the 'In Memoriam' list that it has been a sad year. Our thoughts are with their families. Contact me on 01773 609043 if you have a bereavement and I will contact all the authorities on your behalf, i.e. Chief Constable, Pensions, HR, Mutual Welfare etc. as it can be a very daunting task at this sad time.

As a Branch, through our Chair, David Ashley and the committee, we are endeavouring to make contact with all our members, personally or by phone and email to see if they are well and basically, to have a chat. Can you remember when we were young 'bobbies' we had to do welfare visits, which has sadly gone. So, can you contact me or any committee member by email or phone, to update your contact details. Don't be alarmed if a committee member contacts you!

I would like to thank the assistance afforded to me by NARPO at Wakefield, XPS pension providers, Police Federation, Headquarters staff and members of the Committee.

Although trip costs (coach travel), and admission charges continue to rise, the committee have decided to continue to subsidise coach fares at the present rate. This means that widows will continue to travel free. Members will pay £5 per trip, and non-members will be charged £10 (unless a very long journey is involved, when it may be a little higher.) The only change agreed was that we will no longer reimburse coach fares where there is a cancellation. While the fares are low the cost of reimbursing automatically can no longer be justified. We will of course refund any entrance fees, provided we are not charged by the venue. You will see from the trips that we have organised, that they are not all on a Wednesday. We have a **Tuesday**, **Wednesday** and a **Saturday** for those members still working. You will notice that the Derby pick up is now on Full Street outside the Premier Inn. This is due to the fact that parking spaces at St.Mary's Wharf Police Station are at a premium. Also, for Chesterfield members, we will pick up on West Bars outside the old Court House when we travel North. Otherwise they will have to join the coach at Matlock, Ripley or Derby.
